Reconfirmation Meeting for January

Reconfirm instructional delivery method:

While the district began the year in a virtual status, the most recent state executive order requires the board of education to consider changes to the delivery of education as the situation evolves. The state has mandated that staff members who are able to work from home, should do so. This mandate expires December 8, 2020, but may be extended based upon conditions at that time. The board therefore recommends the following:

1. The students and staff continue in a virtual mode until January 25, 2021.
2. This status will be reviewed in early January.
3. Athletics will remain in a shutdown status. Which will also be reviewed in early January.
4. Buildings will remain open and personnel will rotate attendance on different days to minimize contact.
5. For teachers in synchronous classrooms, the traditional class period will be shortened to allow for office hours.

Reconfirm how instruction will be delivered for each grade level:

Elementary (Grades K - 6):

Students in K-6 will receive 240 minutes of direct instruction via Google Classroom. They will also have the ability to access small group or one-on-one instruction during teacher's 150 minutes of "office hours".

Teachers will be encouraged to record their direct instruction and make it available to students and families for review.

Middle School (Grades 7 - 8):

Students in 7-8 will receive 240 minutes of direct instruction via Google Classroom. They will also have the ability to access small group or one-on-one instruction during teacher's 150 minutes of "office hours".

Teachers will be encouraged to record their direct instruction and make it available to students and families for review.

High School (Grades 9 - 12):

Students in 7-8 will receive 240 minutes of direct instruction via Google Classroom.

They will also have the ability to access small group or one-on-one instruction during teacher's 150 minutes of "office hours".
Teachers will be encouraged to record their direct instruction and make it available to students and families for review.

Reconfirm whether or not the district is offering higher levels of in-person instruction for English language learners, special education students, or other special populations:

Students are offered one-to-one, or two-person group sessions for extra help or support.
